

MetaBoy NFT Contest Terms and Conditions

1. **Sponsor:** The Sponsor of this contest is MetaBoy NFT
2. **Eligibility:** Contest is only open to those who sign up via Discord and are 18 years of age or have parental authorization as of the date of entry and contest participation is lawful in your jurisdiction. The Contest is open worldwide, and is void where prohibited by law. Employees, independent contractors, interns, officers, directors, and agents of MetaBoy NFT, their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited.
3. **Agreement to Rules:** By entering the Contest, the contestant ("You") agree to comply with and abide by these Rules and the decisions of the Sponsor, and you represent and warrant that you meet the eligibility requirements. If the Winner cannot be contacted, is ineligible, fails to claim the prize within 7 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected.
